

FACTS	WHAT DOES KAISER PARTNER FINANCIAL ADVISORS Ltd. DO WITH YOUR PERSONAL INFORMATION?
Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.
What?	<p>The types of personal information we collect and share depend on the product or services you have with us. This information can include:</p> <ul style="list-style-type: none"> <li>▪ Information we receive from you on applications or other forms (E.g. social security number, information regarding your family and income).</li> <li>▪ Information about your transactions with us, our affiliates, or others</li> <li>▪ Account/asset balances</li> </ul> <p>Upon the termination of your customer relationship with us, we will continue to share your information as described in this notice.</p>
How?	All financial companies need to share customers’ personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers’ personal information; the reasons Kaiser Partner Financial Advisors Ltd. chooses to share; and whether you can limit this sharing.

<b>How does Kaiser Partner Financial Advisors Ltd. protect my personal information?</b>	To protect your personal information from unauthorized access and use, we use security measures that comply with Federal law. These measures include computer safeguards and secured files and buildings. We restrict access to non-public personal information about you to those employees who need to know that information in order to provide financial products or services to you.
<b>How does Kaiser Partner Financial Advisors Ltd. collect my personal information?</b>	We collect your personal information, for example, when you <ul style="list-style-type: none"> <li>▪ Open an account or deposit money</li> <li>▪ Pay your bills or apply for a loan</li> <li>▪ Direct us to buy or sell securities</li> </ul> We also collect your personal information from affiliates and your custodians
<b>Why can't I limit all sharing?</b>	Federal law gives you the right to limit only <ul style="list-style-type: none"> <li>▪ Sharing for affiliates' everyday business purposes information about your creditworthiness</li> <li>▪ Affiliates from using your information to market to you</li> <li>▪ Sharing for non-affiliates to market to you</li> </ul> State laws and individual companies may give you additional right to limit sharing
<b>What happens when I limit sharing for an account, I hold jointly with someone else?</b>	Your choices will apply to everyone on your account.
Definitions	
<b>Affiliates</b>	Companies related by common ownership or control. They can be financial and nonfinancial companies. <ul style="list-style-type: none"> <li>▪ Kaiser Partner (Schweiz) AG, Zurich</li> <li>▪ Kaiser Partner Privatbank AG, Vaduz</li> <li>▪ Kaiser Partner Trust Services Anstalt, Vaduz</li> <li>▪ CorTrust reg. <b>Non-affiliates</b>	Companies not related by common ownership or control. They can be financial and nonfinancial companies. <ul style="list-style-type: none"> <li>▪ PQ Solutions LLC</li> </ul>
<b>Joint marketing</b>	A formal agreement between nonaffiliated financial companies that together market financial products or services to you. <ul style="list-style-type: none"> <li>▪ Kaiser Partner Financial Advisors Ltd. does not perform joint marketing</li> </ul>
